# Minutes of London SaRS Branch Annual General Meeting

#### 17<sup>th</sup> May 2017, RSSB, London

1. Colin Dennis (London SaRS Branch Chair) opened the meeting and welcomed the attendees.

2. The Chair presented his report for 2016/17 – see report below

3. The AGM 2016 minutes were received and adopted by attendees.

4. Peter Stanton (SaRS London Branch Treasurer) provided a finance report with nothing significant to report – there has been no Branch expenditure in the year thanks to the support from organisation in providing excellent facilities for the evening events.

5. No resolutions were tabled.

6. Colin Dennis was proposed to continue as Chair of the London SaRS Branch.

10. The attendees held an open discussion. Points raised include:

- The importance of providing topics that support engineers in their preparation for CEng, encourage engagement from the upcoming generation of safety and reliability engineers.
- Engagement with universities is importance, it is not the core activity for SaRS to engage with school age that was discussed at last year's AGM.
- SaRS will move to EventBrite for advertising events, EventBrite can also be used to remind people of events
- Collecting panel questions ahead of events will help improve the quality of post-talk discussions (noting some negative feedback in questionnaire) EventBrite, Twitter could be used for this.
- It was agreed that we should seek feedback on events with simple handout on people's chairs at each event.

- Mott MacDonald on the 21<sup>st</sup> September (Presentations, then a social event hosted by WSP)
- WSP on the 24<sup>th</sup> October (System Assurance).
